The California Food Handler Card law is designed to ensure that cooks, chefs, kitchen staff and other food handlers receive training in the fundamentals of food safety and are equipped with knowledge of modern food safety practices in order to reduce the potential for foodborne illness or food contamination.

### California Food Handlers Card - Certification Courses

Food Handler Certification. Food handlers must obtains a valid California Food Handler's Card within 30 days of hire from a food establishment except for San Diego County. San Diego County requires food workers to obtain a Food Handler Card within 10 days of beginning work. They must be an ANSI/ASTM-2659 course such as this one provided by Learn2Serve.
